This Framework Operation will cover Sub-Projects to be entered into with financial intermediaries targeting primarily one or more of the following Target Areas: (i) Clean Energy Transition-Climate, (ii) Sustainable Transport, (iii) Environment and resources, (iv) Digital Connectivity & Data Infrastructure, in line with applicable requirements.

# FRAMEWORK OPERATION #6 For SMEW RIDW Joint Equity Product – Capital Market Union (CMU) Sub-Product
